"New Global Economy Threats Challenges at a Junction Between Recession and Sustainable Growth"

(Technological, Climate and Demographic Changes)

The key challenge for our scientific conference scheduled in May 2020 and belonging to the traditional cycle "New Economy", are the signals of a possible recession, coming both from the global and regional economic scene. Germany, as Europe's leading economy, has been in the recession for the second quarter in a row. Chinese growth is also limping, with major threats looming over global cross-border investment. Just a decade following the previous world crisis, there are hints that a new one may be upon us.

The conference, scheduled for 22 May 2020, should address in detail the different perspectives on the possible causes, as well as the socio-economic, political, environmental and demographic consequences of the new potential crisis.

The extent of total debts of the economy, citizens and countries of the world today is unknown. On the other hand, the only thing that is clear is that they exceed the Gross Domestic Product (GDP) by several times, and are continuously increasing. The conference participants, in particular, should address the following issues:

- Will the world, Europe, and particularly the region of South-Eastern Europe (the Balkans), be hit by a new recession?
- What would the new economic crisis, like the one from the year 2009, mean to the world of today?
- Has the world managed to learn anything from the experience of the overinflated financial bubble of the mortgage crisis, from the first decade of the 21st century?
- What would be the epilogue of the latest deterioration of the relationships between the largest global players, embodied in events such as customs wars, shifting the spheres of influence of the great powers, and the sudden reconfiguration of global power dominance?
- Why does the majority of the today's world of today remain silent and dormant to the obvious protectionism?
- What is the extent of the impact of the international community, the UN, or the International Financial Institutions of the World Bank or IMF, to the global economic trends, as well as to political relations of cooperation that are still being promoted?
- What are the possible key triggers of the crisis mechanism? Is there a multiple-wave recession in sight, or will it be just a single episode of a decline in the average growth rate of the world economy?
- What will the economic trends of Asia be like, in comparison to Europe and North America?
- Is there a chance for regional economies to stumble, while maintaining the positive global growth, thanks to new major players on the world stage, such as India, Vietnam
- What could the new crisis mean in terms of multilateralism, technological cooperation and global climate action?
- How cooperative is the international scene today, and how much is the global community of peoples willing to "learn" from the errors and mistakes in their conduct,

Certainly, it is very difficult to view all these issues in the face of uncertain events, but each one of them is a challenge placed before the analysts. Any attempt is a prerequisite for success, particularly if things are put in the context of synergistic efforts, collective critical awareness and the goodwill of the participants, as it has been the case so far.
